McHenry County Department of Health

State of Illinois

Governor JB Pritzker announced the creation of a [centralized state website](#) detailing the state's evolving response to the COVID-19 pandemic. The website includes news, prevention information, preparation efforts, FAQs, resources and more information about coronavirus.

On May 5, 2020 Governor Pritzker presented [Restore Illinois](#), a five-phase plan to safely reopen the state. The state is divided into four regions, each of which could enter different phases of reopening at different times.

What Does the Governor's Extended and Modified Stay at Home Executive Order Mean?

[Executive Order 2020-32](#) allows Illinoisans to leave their home for essential activities, including for health and safety, for necessary supplies and services, for outdoor activity, for certain types of work, to take care of others, and to engage in the free exercise of religion, but otherwise requires them to stay at home or their place of residence to prevent spread of COVID-19. Individuals are required to wear a face covering in public places when they are unable to maintain a six-foot social distance, such as in stores. The order defines essential businesses and operations. Non-essential retail stores may fulfill online and telephonic orders through pick-up outside the store or delivery.

While you're keeping 6 feet of distance between yourself and other pet owners, be sure to give your pet equal distance from other animals. The Centers for Disease Control and Prevention now recommends pet owners keep their dogs, cats and hamsters from close contact with other animals after two domestic cats in New York tested positive for the virus.

The CDC says [in the updated advisory](#) that "based on the limited information available to date, the risk of animals spreading COVID-19 to people is considered to be low. We are still learning about this virus, but it appears that it can spread from people to animals in some situations".
